

## Privacy Policy

Please read this Privacy Policy carefully as it will help you make informed decisions about sharing your personal information with us.

### Introduction:

“OJARH” is thoroughly committed to protecting the privacy of our site visitors and customers. We fully appreciate and respect the importance of privacy on the Internet. We respect each visitor's and customer's right to personal privacy. To this end, we collect and use information throughout our website only as disclosed in this Privacy Policy.

General information in line with extant laws and regulations.

This policy does not apply to the practices of third-party agents or people over whom we do not exercise direct control, employment, or management.

### 1. Consent:

By using this site, you have consented to our Privacy Policy and that has the legal capacity to give consent. Otherwise, you may discontinue and log out at this stage.

### 2. Collection of Personally Identifiable Information

We collect personally identifiable information (including but not limited to email address, name, phone number, physical address, location, photo, banking details (when you make purchases), online identifiers, etc.) from you when you set up a free account with “OJARH”. While you can browse some sections of our site without being a registered member, certain activities (such as placing an order) do require registration. We do use your contact information to send you offers based on your previous orders and your interests. The information and personal data are as freely provided by you to us using any technology at the material time e.g. JWT, web tokens, etc.

### 3. Use of Demographic and Profile Data

We use personal information to provide the services you request. To the extent we use your personal information to market to you, we will provide you the ability to opt-opt out such uses. We use your

personal information to resolve disputes; troubleshoot problems; help promote a safe service; collect fees owed; measure consumer interest in our products and services, inform you about online and offline offers, products, services, and updates; customize your experience; detect and protect us against error, fraud and, other criminal activity; enforce our terms and conditions; and as otherwise described to you at the time of collection. In our efforts to continually improve our product and service offerings, we collect and analyze demographic and profile data about our users' activity on our website. We identify and use your IP address to help diagnose problems with our server and to administer our website. Your IP address is also used to help identify you and to gather broad demographic information. We will occasionally ask you to complete optional online surveys. These surveys may ask you for contact information and demographic information (like location, local government area, age, or income level). We use this data to tailor your experience at our site, providing you with content that we think you might be interested in--and to display content according to your preferences.

#### 4. Cookies

We use cookies to collect information. A "cookie" is a small piece of information stored by a Web server on a Web browser so it can be later read back from that browser. Cookies are useful for enabling the browser to remember information specific to a given user ojarh.com places both permanent and temporary cookies in your computer's hard drive. Ojarh.com's cookies do not contain any of your personally identifiable information or private data. We use technology in collecting information in order to make our Sites and other content or services which we make available to you more interesting and useful to you. a. b. Personal data shall be adequate, accurate and without prejudice to the dignity of the human person:

c. Personal data shall be stored only for the period within which it is reasonably needed, and shall be secured against all foreseeable hazards and breaches such as theft, cyberattack, viral attack, dissemination, manipulations of any kind, damage by rain, fire or exposure to other natural elements.

d. Our data collection shall depict that we owe a duty of care to you.

e. We shall be accountable in line with extant laws and regulations.

## 6. Sharing of personal information

We may share personal information with our other corporate entities and affiliates to help detect and prevent identity theft, fraud, and other potentially illegal acts; correlate related or multiple accounts to prevent abuse of our services, and facilitate joint or co-branded services that you request where such services are provided by more than one corporate entity. Those entities and affiliates may not market to you as a result of such sharing unless you are explicitly opt-in. We may disclose personal information if required to do so by law or in the good faith belief that such disclosure is reasonably necessary to respond to subpoenas, court orders, or other legal processes. We may disclose personal information to law enforcement offices, third-party rights owners, third-party vendors, contractors, and suppliers who perform services for us or on our behalf and require access to such information to do that service, or others in the good faith belief that such disclosure is reasonably necessary to: enforce our Terms or Privacy Policy; respond to claims that an advertisement, posting or other content violates the rights of a third party; or protect the rights, property or personal safety of our users or the general public. ojarh.com and its affiliates will share some or all of your personal information with another business entity should we (or our assets) plan to merge with, or be acquired by that business entity. Should such a transaction occur, another business entity (or the new combined entity) will be required to follow this privacy policy with respect to your personal information.

## 7. Personal Data Retention Period

Ojarh.com will only keep your personal information for as long as it is necessary for the purposes set out in this Privacy Policy unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements.) Upon request for account closure, your account will be closed but this closure will not involve the deletion of historical records of the account for the reasons already stated. However, except as may be required by law or law enforcement agents and/or regulators, further processing of the personal information related to the account will cease from the time of closure.
